He has a global reputation as a market historian and a technical analyst, providing unique insights on market timing and related investment strategy issues. **Chief Executive Officer**


**Richard Bernstein Advisors LLC**

Damodaran has been the recipient of Giblyn, Glucksman, and Heyman Fellowships; a David Margolis Teaching Excellence Fellowship; and the Richard L. Rosenthal Award for Innovation in Investment Management and Corporate Finance. His skill and enthusiasm in the classroom garnered him the School of Business Excellence in Teaching Award and the Distinguished Teaching Award from NYU. Damodaran received a BA in accounting from Madras University and an MS in management from the Indian Institute of Management. In that capacity, he serves on the Federal Open Market Committee, the Federal Reserve System's monetary policymaking body. As head of the Chicago Fed, Evans oversees the work of roughly 1,400 employees in Chicago and Detroit who conduct economic research, supervise financial institutions and provide payment services to commercial banks and the U.S. government. Before becoming president in September 2007, Evans served as director of research and senior vice president, supervising the bank's research on monetary policy, banking, financial markets and regional economic conditions. His personal research has focused on measuring the effects of monetary policy on U.S. economic activity, inflation and financial market prices. He has been published in the Journal of Political Economy, American Economic Review, Journal of Monetary Economics, Quarterly Journal of Economics and the Handbook of Macroeconomics. Evans earned a bachelor's degree in economics from the University of Virginia and a doctorate in economics from Carnegie-Mellon University in Pittsburgh.

Bob Froehlich brings more than 35 years of Wall Street experience where he chaired investment committees for multiple global asset management organizations including Deutsche Bank, Hartford and Kemper Funds. Recognized as one of the top economics reporters and anchors in the country, Hays has covered the U.S. economy and the Federal Reserve for more than 20 years. She joined Bloomberg in 2006 after years as an on-air and online economics correspondent at CNN, CNNfn, and CNBC, where she served as a host, correspondent and commentator for numerous programs including "Squawk Box." Hays began her career as a print journalist, initially serving as a founder, director, economics correspondent and New York bureau chief at Markets News International, a financial news service. From there, she joined Reuters, where she covered domestic and global bond and currency markets as well as central bank policy. She later worked as an economics correspondent and New York bureau chief for Investor's Business Daily. Hays attended Stanford University where she earned both a bachelor's degree and a master's degree in economics. She is based in New York City.
